26/05/21 Vet attended for Huggy due to Huggy's breathing being laboured. Vet prescribed ventipulmin and advised inhaler be increased.

05/06/21 Vet attended Huggy for colic. He recovered well following treatment. Due to Huggys age and condition, his weight carrying limit has been significantly reduced and the ECC will be looking for a suitable retirement home for him in the future.

11/06/21 Farrier attended. We still need to take measures to prevent Rupert pulling off his shoe. Sam and Rupert were turned out 24/7 separated from the herd 11/06/21.

13/06/21 Ellie had a thermal imaging session, report pending. Lolly and Ellie are rapidly increasing weight, they joined Rupert and Sam 14/06/21

21/06/21 The vet is due for routine vaccinations and blood tests.
